All birds are free lofted in aviaries, each aviary varies in size dependant on the bird being housed, each aviary has adequate shelter and the owls also have owl boxes within their aviaries. Every aviary is secured using a combination padlock and the centre itself is protected with an alarm system. Our birds are all housed individually as they are only

used for flying and not breeding or solely for display.				
X2 small aviaries for little owl and southern whitefaced, x7 owl aviaries all with internal owl boxes, x 11 chambers for hawks and falcons				
A variety of perches are available in each with varied covering to reduce the risk of corns etc				
Maintenance and well-being

Aviaries are cleaned daily, birds equipment checked and also their health and general wellbeing. All birds are weighed daily unless moulting and records are kept of daily weight, flight performance, condition and food given.				
Food is stored in the food preparation room, food stored in freezer and defrosted then kept in fridge and we have a stainless steel sink and drainer used for preparation, food room is cleaned twice daily				
Birds are wormed monthly, they are all fed a varied diet and everywhere is kept clean ensuring they remain in as good health as possible, we have a local veterinarian on hand at any time to offer support and advice

We intend to promote education and awareness through our continued school visits, daily falconry displays and activity days. We also feel it is important to educate on the care and wellbeing of captive bred birds to try to avoid so many birds being kept poorly in captivity as "pets", we do this through our displays and talks on a daily basis

The centre has numerous information available relating to our native birds of prey and their conservation and this is also something we touch heavily on in talks and displays especially the plight of our native Barn Owl

It is also of huge importance to us to educate in respect of our native wildlife not just birds of prey, we do this through pond dipping, nature trails, mini beast hunting and native songbird feeding and housing

We also are involved in breeding projects with Thorp Perrow and plan to continue this further into the future
