2nd Period Registration of Summary Objects - Parish Council have agreed to modification

No. and date of entry	Description of the land, reference to the register map, registration particulars etc.
1. 8th May, 1969	Those pieces of land called the Village Green Bishopton containing 2.483 acres or thereabouts in the Parish of Bishopton in the Rural District of Darlington as marked with a green verge line inside the boundaries on sheet B621 of the register map and distinguished by the number of this register unit. Registered pursuant to application No. 212 made 24th June, 1968 by A.R. Greathead, Clerk of the Bishopton Parish Council 11 Church View, Bishopton, Stockton-on-Tees on behalf of the Parish Council. (Registration Provisional).
2. 3rd July, 1973.	The registration at Entry No. 1 above, which was disputed, became final on the 3rd July, 1973, with the following modification:- that the words "but excluding the areas coloured violet and marked with the letters A,B,C,D,E,F,G,H,I,J,K,L,M,N." follow immediately after the words "of the register map" in entry No. 1 above.
