Darlington Borough Council is preparing a Publication Draft Core Strategy, which is the principal document of the Local Development Framework (LDF). The LDF is a set of documents which will eventually replace the adopted Darlington Local Plan. It sets out how the Borough will develop over the next 15 years (2011-2026), providing the spatial planning framework for the many plans and strategies prepared by the Council and its partners. In particular, it will help to deliver spatially the priorities of the sustainable community strategy 'One Darlington: Perfectly Placed'.

The Core Strategy and other development plan documents of the LDF will form part of the statutory Development Plan for the Borough which will inform a range of implementation plans and decisions on planning applications.
